- 2.2 There won't be any age relaxation for the above positions.

- 2.3 All minimum essential qualification(s) must be from UGC recognized Indian University/UGC recognized Indian Deemed University or AICTE approved courses from Autonomous Indian Institutions/ concerned statutory council (where ever applicable) or The Institute of Chartered Accountants of India for CA/ Institute of Cost Accountants of India for ICWA.
- 2.4 Minimum percentage of marks in the essential qualification (s) as specified shall be considered as per institute / University rules / norms.
- 2.5 Whenever CGPA/OGPA or letter grade in a degree is awarded, equivalent percentage of marks should be indicated in the application form as per norms adopted by University / Institutes.
